

Benefits of Citizenship

The right, but not the obligation, to live and work in St.Kitts and Nevis Visa-free travel, including Visas-onarrival, to more than 155 to future generations destinations Dual citizenship allowed under the laws of St.Kitts and Nevis

Citizenship may be passed

Family Inclusion

The following members may be included in an application for citizenship by investment.

- ✓ Spouse
- Children of the main applicant or of the spouse, if:
 - Aged under 18
 - Aged 18 to 30 and in a dependency relationship with the parents
 - Aged 18 or over and physically or mentally challenged
- ✓ The brother or the sister of either the main applicant or of the spouse, if unmarried, childless, 30 years of age or younger, and financially dependent on the main applicant
- ✓ Parents of the main applicant or of the spouse if aged 55 or above, and living with and fully supported by the main applicant
- ✓ Grandparents of the main applicant or of the spouse if aged 65 or above, and living with and fully supported by the main applicant

The Investment

There are four investment options in St. Kitts and Nevis:

1 SGF Option

A contribution to the Government's Sustainable Growth Fund (SGF), Under a Limited Time Offer due to expire on 31 December, 2021. The following costs apply.

✓ Main applicant	US\$150,000
✓ Family of up to four	
✓ Each additional dependent after the third	
US\$20,000 is due for a sibling)	

2 Pre-Approved Real Estate Option

The purchase of pre-approved real estate. Pre-approved real estate purchasers have two choices:

• Minimum independent investment in property to be held for 5 years: US\$400,000 (with any number of applicants).

■ Minimum joint investment in property to be held for 7 years; US\$200,000 per investor (total value of the investment: US\$400,000).

3 Private Home Option

Until 1 November 2022, applicants can purchase a private home worth US\$400,000 to qualify for citizenship. Two or more main applicants may also apply together provided they each contribute US\$400,000 towards the property. The property must be held for a period of five years and can never be reused in a subsequent citizenship by investment application.

4 Alternative Investment Option

Applicants can invest in an approved infrastructural project or other approved development project. The project must be approved by the St. Kitts Investment Promotion Agency and Cabinet. The cost of the Investments is US\$200,000 where the project will eventually be owned by a private entity, and US\$175,000 if the project will eventually be owned by the State.

The following Government Fees apply to the pre-approved real estate option, private home option, and alternative investment option where the project will eventually be owned by the State:

\checkmark	Main applicant	US\$35,000.00
√	Spouse	US20,000
√	Sibling	US\$40,000
	Any family member other than the Spouse or a sibling	

The following Government Fees apply to the alternative investment option where the project will eventually be owned by a private entity:

- ✓ Any additional family member other than the spouse (included in the family of four) and a sibling

The following basic fees apply to <u>all four</u> options:

An <u>Accelerated Application Process (APP)</u> option can be selected for a premium fee. The APP covers all basic fees except for Bank Due Diligence Fees, Certificate of Registration Fees, and CS Global Partners Professional Fees.
